In May of last year, the society received ownership of the lighthouse from the Department of the Interior. A watercraft was purchased to allow members to travel out to the structure and begin assessing and securing the building. Some minor repairs and cleaning were completed during the eight trips out to the light. Divers were also engaged to assess the condition of the existing power cable which is situated on the floor of the lake. We have been in contact with a Canadian company that designs and installs floating dock systems. The funds we have been awarded from the Lake Erie Protection Grant will provide half of the cost of this project. Board members have met regularly during the winter to discuss projects and complete grant applications. The society is in need of volunteers who would be willing to work out at the lighthouse this summer, help with grant writing, and assist with fund raising. Your help will ensure that our goals will be realized.

Grant Awarded

The board has recently been notified that our grant application to the Lake Erie Protection Fund has been approved for \$15,000.00. This grant will be utilized for the floatation dock system that will be installed adjacent to the lighthouse, this summer. The dock will be a U shape with a multilevel gangway that floats with the rising waves. The dock will be put on the sheltered side of the lighthouse which will be the west side. This system will provide easy access to those working on the restoration of the building as well as future visitors. Board members recently met with graduate students from Cleveland State University who will be conducting a search of available grants that would be applicable to our society. Their enthusiasm for our project as well as their expertise is most welcomed.

Message from Our V.P.

During our visits to the lighthouse last summer we were able to work on several doors and windows as many of the hinges were frozen or broken. The roof and walls of the structure were evaluated and found to be in stable condition but will need attention this summer. Signs were installed on the exterior of the building, as instructed by the National Park Service. We are inquiring about the purchase of a portable toilet for the lighthouse and are also in contact with an engineering firm to conduct a Condition Assessment Report to help us prioritize the most urgent stabilization needs. We will continue to assess the possibility of connecting the power cable but are also actively pursuing funds for a generator.
